

## Privacy Policy

Dutch Gelderland Group bv attaches great importance to the protection of your personal data. In this Privacy Policy we want to provide clear and transparent information about how we handle personal data.

We make every effort to ensure your privacy and therefore handle personal data with care. Dutch Gelderland Group bv is in all cases subject to the applicable laws and regulations, including the General Data Protection Regulation. This implies that we at least:

- To be aware of your rights regarding your personal data, to point this out and to respect them.

## Processing of personal data of users contact form.

Your personal data are stored by Dutch Gelderland Group bv for the above mentioned processing (s) for the period:

- During the term of the agreement and thereafter only in the financial administration for a maximum of 7 years.

## Processing of personal data of newsletter subscribers

Personal data of newsletter subscribers are processed by Dutch Gelderland Group bv for the following objective (s):

- Informing the person by means of news.

The basis for this personal information is:

- The registration form Newsletter;

For the above objective (s), Dutch Gelderland Group bv may request the following personal data from you:

- First Name;
- Insertion;
- Last name;
- Address
- Residence
- E-mail address.

Your personal data are stored by Dutch Gelderland Group bv for the above mentioned processing (s) for the period:

- During the period that you are registered.

## Rights concerning your data

You have the right to inspect, rectify or delete the personal data we have received from you. You can also object to the processing of your personal data (or a part thereof) by us or by one of our processors. You also have the right to have the data provided by you transferred by us to yourself or by order of you directly to another party. We can ask you to identify you before we can comply with the aforementioned requests.

May we process your personal data on the basis of a permission given by you, you will always have the right to withdraw this consent.

### Complaints

If you have a complaint about the processing of your personal data, we ask you to contact us directly. If we do not come together with you then we find this very annoying. You always have the right to file a complaint with the Dutch Data Protection Authority, this is the supervisory authority in the field of privacy protection.
